The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

In order to comply with Allerdale Borough Council's Code of Conduct, a Member or Co-opted Member ("M") must register their pecuniary and interests other than pecuniary interests with the Council's Monitoring Officer within **28 days** of the date of their election or co-option (Failure to declare a disclosable pecuniary interest is a criminal offence).

You may complete the form electronically but you must print out and personally sign the completed form.

If in doubt about whether or not something should be declared, you are urged to err on the side of openness and avoid the risk of not registering something in error.
