184/11 CHAIRMAN'S ANNOUNCEMENTS

The Chairman announced that he would circulate proposed meeting dates for the second half of the year.

The Chairman noted that he had made a report to the Highways Hotline regarding flooding/icing on Main Street. He had been impressed at speed and efficiency of the response.

186/11 PUBLIC PARTICIPATION

The Chairman did not adjourn the meeting to allow members of the public to speak as there were none present.

The Council received a report of a recent arrest.

Cumbria Constabulary advised on the introduction of Cumbria Community Messaging managed by Cumbria Neighbourhood Watch Association and is a means for individuals to receive crime information from Cumbria Police. 188/11 MATTERS ARISING FROM THE MINUTES

Meeting House Lane

It was reported that the road had been closed for the wall to be repaired and that this work was now complete.

The railings have not yet been repaired. Cumbria Highways have indicated that this will be done within the coming months.

The Church will contact United Utilities regarding advice on water runoff onto the roadway. The Council will investigate whether a multi-agency group can be convened to help.

The Council will request that the gate be reopened for the safety of pedestrians.

Drainage/flooding

The Council had received notification of flooding by the Craggs Hotel and at Coldgill. Councillors will provide photographic evidence where possible and these will be forwarded to the Highways Authority.

Parish Salt scheme

A definitive map of the location of grit bins has been sent to the County Council.

Allotment sub committee

Cllr Smith was appointed to the allotment sub committee and a meeting was scheduled.

Footpaths

Cllr Oldfield reported that he had sent documentation to CCC regarding the Rights of Way Improvement Plans at Craggs Quarry and at Soddy Gap.

The Council discussed the ownership of the land on which the footpath runs between South Terrace and Camerton Road. The Council did not reach a conclusion and will make further investigation.

Church Meadows

Cllrs Cockburn and North offered to ascertain the details of the site manager from officers at Allerdale BC.

Cllr Hobden reported that the plans finally passed contained provision for the churchyard extension but not for any community building.

War memorial

The Council had received quotations from 2 companies for the restoration and repainting of the war memorial. The Council **agreed** to accept the estimate from Robertson's for £536.50. It is understood that the Royal British Legion and Christ Church will make contributions towards this cost.

The Council will consider the issue of the addition of names formerly omitted from the memorial.

Allotments

The subdivision of land at Coldgill Avenue is now complete and 10 new allotments have been formed. All have been allocated to those on the waiting list.

WREN report and photos

The Council will complete the report to gain funding from WREN for the new playground. The report requires a number of photographs of the equipment in use.

Fields in trust – Have a Field Day

The Council will consider the opportunity of entering the Welfare Field to the Queen Elizabeth II Fields Challenge.

It is understood that the Village Hall committee is organising Diamond Jubilee celebrations for 100 people on June 5th.

The handyman will be asked to advise on the best method to achieve a stable, level entrance to the playground.
